

**FACT SHEET**  
**THE 15<sup>th</sup> EUROPE ASIA MEDICAL & LEGAL CONFERENCE**  
**LAKE COMO, ITALY**  
**LATE JUNE – EARLY JULY 2013 (exact dates TBC)**

*This conference will run before the Istanbul/Gallipoli and London/Stratford-upon-Avon Medical & Legal Conferences July 2013*

One test for a good conference is its track record. Judging by the comments of delegates this conference has had the enthusiastic support of attendees from the 5 previous conferences at Lake Como, approving content format and venue.

**LAKE COMO** is described by a Pulitzer Prize winning journalist as one of those points where heaven meets earth. The conference venue is the Hotel Regina Olga, on Lake Como's edge, in the village of Cernobbio. The lake's shore is dotted with picturesque villages, housing ancient villas surrounded by luxuriant gardens. A regular ferry makes these villages accessible for a morning excursion. Anywhere you can taste wonderful Italian cuisine (without a lot of searching) at reasonable prices. Classically outdoor dining is de rigeur. At night, having something more sophisticated to slip into is in keeping with local style. The famous Villa D'Este is a short walk from the conference venue and for some wicked indulgence may be worth a night's stay. For sailboarders and sailors, Lake Como is a world championship venue (boats and sailboards are for hire). You will experience the delights of a northern Italian summer, the way Europeans have for centuries. Lake Como is also one of those cultural cross-roads of Europe where you will hear English, Italian, French and German spoken. Horse-riding, walking in the hills, a round of golf, hiring a bicycle or just spending a day walking round the ancient centre of the city of Como are wonderful ways to take in the region. Poking about some of the shops in Como or one of the villages reveals moderately priced antiques, places to buy local art and exquisite silks. Or travel the few miles to Switzerland for morning tea. Milan is also easily accessible by car or train.

**The academic and professional program** has always been the centre piece of our conferences, but an equally important part is the networking activities we organise outside of the formal program. Over the years many delegates have forged professional links with other practitioners arising out of meeting for the first time at the conferences. The synergy of medical and legal practitioners at these conferences has led to a greater understanding of each other's role and broken down many barriers. Delegates have also reported that the informal interaction with other delegates has led to an exchange of ideas and methodologies, and an enhancement of professional camaraderie among fellow practitioners including referrals from both fellow medical practitioners and lawyers. Many delegates are now coming to these conferences as individuals because of the camaraderie and networking events associated with the conferences.

## **ACCOMMODATION**

Conference venue is the Hotel Regina Olga (Via Regina, 18 - 22012 CERNOBBIO Como) on the lake's edge. Prices in 2010 started at \$AUD420\* for a double room per night including breakfast (the second person occupying that room is free of charge). Single occupancy was \$AUD330\* per night including breakfast and a triple room was \$AUD480\* per room per night including breakfast. Prices for 2013 will be finalised closer to the conference commencing

We will have 2 other hotels available for the conference: they are Hotel Miralago, which is a 3 star hotel next door to the Regina Olga and Hotel Centrale located across the road from Hotel Regina Olga. Prices for 2013 are yet to be confirmed.

## **SOCIAL EVENTS**

We will organise a number of social events including a conference dinner on the first night, a sunset cruise and dinner on Isola Comacina, the only Island on Lake Como and a bus trip to Switzerland for some shopping at Foxtown (*brand factory outlet*) – being an opportunity to pick up some wonderful designer wear. We'll also offer a trip to the famous gardens of Villa Carlotta hopefully to take in a concert there. *The registration fee does not include the cost of the social events.*

## GETTING THERE

---

Hotel Regina Olga can be reached from the Como-North highway, from the **Milan** airports (Malpensa, Linate and from **Switzerland**). There are 3 Milan airports; Malpensa, the main international airport 50 km north of Milan; Linate, the main domestic Milan airport with some international services; and Orio al Serio, the budget airlines airport ([www.sacbo.it](http://www.sacbo.it)), closer to Bergamo rather than Milan. Lake Como's closest airport is Lugano, Switzerland, (see [www.lugano-airport.ch](http://www.lugano-airport.ch)), about 40 minutes by car to Cernobbio. Swiss Air flies to Lugano via Zurich.

## REGISTRATION

Registration cost is \$AUD1100 for single registration or for multiple registrations, \$AUD850. Accompanying persons not needing formal registration are free and are welcome to attend all functions and sessions. Please note that rooms will be allocated strictly in accordance with the receipt of the registration fee. If for any reason you wish to cancel your registration (even at the last minute), we will refund your registration fee less an \$AUD100 administration charge. Accommodation once paid can only be refunded at the hotel's discretion.
